

## City of Baker School Board July 7, 2020

## MINUTES

The City of Baker School Board held a School Board Work Session at 5:00 p.m. with public meeting to follow beginning at 6:00 p.m. on July 7, 2020, via Zoom virtual media/teleconferencing.

The School Board Work Session was to review and discuss the Health Care and Supplemental Insurance Packages for the 2020 – 2021 enrollment plan year and to discuss the Preliminary Operating Budget for the 2020 – 2021 fiscal year.

A moment of silent meditation was led by Mrs. Burges, followed by the Pledge of Allegiance led by Mrs. Parker. Ms. Booker welcomed all visitors participating in the meeting.
